The facility will help manage increasing wastewater demands from rapid residential development and meet an accelerated timeline driven by continued growth in the region.

To support the City in meeting this commitment, Burns & McDonnell will implement a fast-tracked interim wastewater management system while concurrently designing the permanent facility.
